General Information:

- 1) The City of Tallahassee’s Lobbyist Registration Ordinance, the supplemental Rules & Regulations, and general information can be found accessed online at: [www.talgov.com/transparency/lobbyists](http://www.talgov.com/transparency/lobbyists)
- 2) Each lobbyist is required to submit their own registration forms and filings, with the Lobbyist’s signature affixed thereto. A separate registration form shall be submitted by the Lobbyist for each Principal represented. Staff will review each submittal and incomplete or defective filings will be returned to the Lobbyist for correction. Staff cannot accept incomplete or defective filings.
- 3) Each Issue must be registered prior to lobbying on said Issue. Each lobbyist shall amend their registration to disclose each new Issue prior to commencing any lobbying activities thereon. Lobbying on an unregistered Issue is prohibited and is grounds for enforcement action. Forms lacking the required specificity as to the Issue being lobbied will be returned to the Lobbyist for correction. To register additional Issues for the Principal, an Add Issue form is available on the City website.
- 4) The registration fee is **\$500.00** per lobbyist, per year in compliance with Section 2-339 of the Code of General Ordinances and Fee Resolution 22-R-22. Fees are not prorated. The fee is a flat fee levied once per year, at the time of initial registration. The yearly fee encompasses all Principals and Issues, and there is no additional fee to add additional Principals or Issues during the calendar year.
- 5) Completed forms may be scanned and emailed to [lobbyists@talgov.com](mailto:lobbyists@talgov.com), hand delivered, or mailed to the address below. For those submitting electronically, **registration is not effective until applicable fees have been paid and the form has been reviewed and accepted by staff.**
- 6) All registrations expire at midnight each December 31<sup>st</sup>. A new registration must be filed, and a new registration fee paid for each calendar year in which lobbying occurs.
