### *Statement of Issue*

On January 25, 2012, the City Commission adopted Policy 102 and Policy 103, designated Reimbursement and Recovery of Attorney's Fees and Costs in Criminal and Ethics Complaint Cases, respectively. These policies sunset five years from the date of adoption.

### *Recommended Action*

Option 1. Re-approve City Commission Policies 102 and 103.

## Supplemental Material/Issue Analysis

### *History/Facts & Issues*

The common law in Florida as set forth in court cases and Attorney General Opinions clearly establishes the right of public officials, officers, and employees to be relieved of the financial burden of defending themselves when ethics complaints or criminal charges arise out of or in connection with the scope of their public employment while acting in their official capacity in serving a public purpose and where the official, officer, or employee successfully defends or prevails in such action. In 2012, the City Commission, through the adoption of Policy 102 and Policy 103, designated Reimbursement and Recovery of Attorney's Fees and Costs in Criminal and Ethics Complaint Cases, respectively, formalized these legal provisions into written policies. The policies define (1) the persons to whom the policy applies, i.e. all City officials, officers, and employees; (2) the necessary conditions under which payment will be made; and (3) the process for payment of fees. Both policies will sunset as of December 6, 2022, and the City Attorney's Office is recommending re-approval. A five year or December 7, 2027, sunset date is recommended. The proposed policies are attached. The only revision is the correction of a scrivener's error in Section 103.09 of City Commission Policy 103.
